Condition for issue of Tender Paper :

- 1) The tenderer should have minimum 03(three) years experience as on 31.03.2015 in works of similar nature.
- 2) The tenderer should have successfully completed the following works during the last seven years.
 - I) One similar work of value not less than 80% of the value of work.
 - II) Two similar works of value not less than 50% of the value of the work.
 - III) Three similar works of value not less than 40% of the value of the work.
